As per provision under Sub-Section 8.B of Section 8 of the Assam Start Up Policy, 2017, a Start Up Council is hereby constituted for governance purposes, proper programme management and administration of the Start Up Policy of Assam, 2017 with the following members:

1.	Senior most Secretary of Industries & Commerce Department	Chairman
2.	Commissioner of Taxes, Assam	Member
3.	Managing Director, Assam Skill Development Mission	Member
4.	Director of Technical Education	Member
5.	Director of Higher Education	Member
6.	Managing Director, APDCL	Member
7.	One representative of Assam Police to be nominated by Director General of Police, Assam	Member
8.	One representative from Bank/ Financial Institution to be nominated by the Chairman	Member
9.	One representative from Industries and Trade Associations to be nominated by the Chairman	Member
10.	Three representatives from academic institutions to be nominated by the Chairman	Member
11.	Commissioner of Industries & Commerce, Assam	Member Convener

Terms of reference of the Committee are as follows:-

1. The Council shall monitor the implementation of the Start Up Policy of Assam, 2017 and responsible for overall implementation of the Policy.
2. The Council may approve the fiscal and non-fiscal incentives under the Policy.
3. The Council may sit as and when required but at least twice in a year.
4. The Council may co-opt any member/ expert for any meeting.
5. The Start-Up Council shall also revisit the Policy document from time to time to review and suggest recommendations to the State Level Implementation Committee to realign it as per the changing needs of the Start-Up business community.
6. The Council may take up any issue relating to incubation centre, sanction of fund, hiring of manpower etc. in the interest of effective implementation of the policy; and also to approve a set of guidelines for the implementation of the Policy.
7. The Council may constitute a sub-committee to issue "My Assam start up ID (MASI)" under the Policy.
8. The Council may take necessary decisions on implementation of Online Assam Startup Portal, Mobile App, creation of Helpline, Massive Open Online Course (MOOC), setting up of Incubation centres etc.
